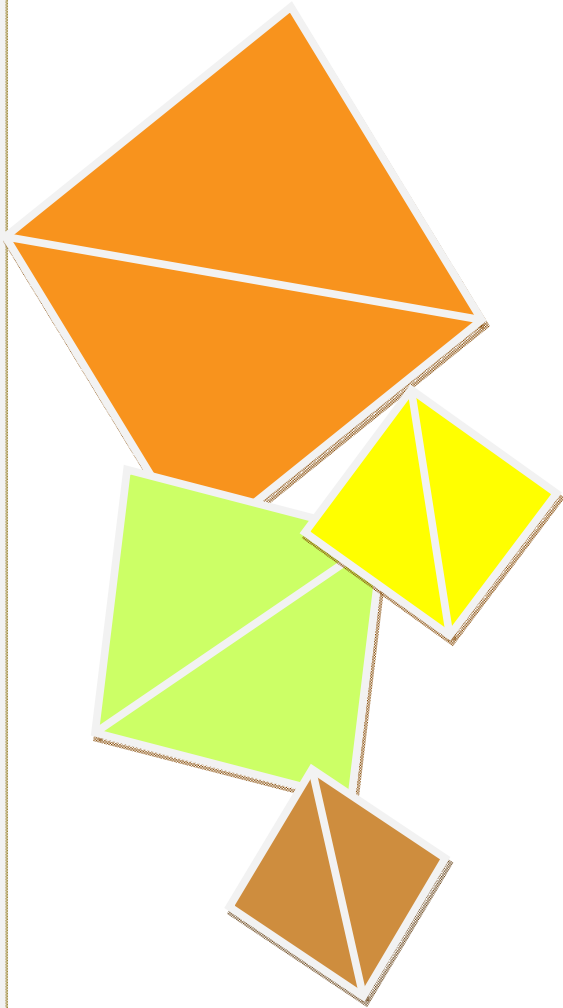


12TH NATIONAL CONFERENCE
